PROGRAM INFORMATION

Registration Deadline: Monday, February 24

Registration Fee: \$200 per team. 10 games guaranteed.

Registration Procedure: Teams must submit a completed registration form along with full registration fee on or before the deadline.

Tentative Start Date: Week of March 3

Play Days: Weekday evenings between 6pm and 10:30pm

Teams will be scheduled for up to 2 games per day and up to 3 games per week.

Location: Watauga Community Recreation Center

MANDATORY CAPTAIN'S MEETING: Thursday, February 27 at 5:30 pm at the Watauga Community Recreation Center (231 Complex Dr, Boone)

Uniforms: Teams are required to have matching uniforms with permanent, legible, NFHS legal numbers on the front and back. Reversible jerseys are highly recommended. In the case two teams have identical or similar colored jerseys, the home team will be required to wear jerseys supplied by Watauga County Parks and Recreation. A limited number of jerseys will be available for teams to borrow for the season.

Eligibility: Players must be residents of Watauga County or a full-time students at an accredited school located in Watauga County. Participants must be 16 years of age or older to be eligible to participate in the Men's or Women's leagues. To be eligible for the High School league, participants must be current students at an accredited high school. Proof of high school enrollment is required at or by the first game.

League Information:

- If registration numbers are not significant, divisions may be combined.
- Games will be played 3 V 3 with a **maximum of 6 players per team per game.**
- Games will played half court and consist of 2 - 10 minute halves with a running clock.
- Double headers will be scheduled.
- Participants may only play in one 3V3 league and may play for only one team.
- Cash, check, Master Card, Visa & Discover accepted. Make checks payable to Watauga County Parks & Recreation.
