**Program Review** with the Division September 27<sup>th</sup> & 28<sup>th</sup> with Rick McSwain and John Beck.

## Blue Ridge Environmental Consulting - Derrick Goddard

Mr. Goddard discussed the EQUIP program that has funds. The Project on Todd-Willett miller Road. The Landowner partners and gets 100% funded by USDA except Admin parts. The Division of Water Resources applies for matching funds. He wants permission to apply. Applications are due in December. Project is \$186258.00 which also covers design and permitting. Board will need to approve Resolution to partner. Project will cover well, stream crossing, exclusion fencing, water tanks.

Chris Hughes asked if it would be an increased workload for staff.

Derrick Goddard stated that no, it would be a turn-key project.

Denny Norris – We encourage our staff to check on the project and learn.

Derrick Goddard – Mikey Woodie is copied on all parts of the project.

Chris Hughes made a motion to sign Resolution. Bill Moretz 2<sup>nd</sup>. Motion approved.

**Blue Ridge RC&D Jessica Janc -** Preliminary design for Jensen restoration. No update on **Watauga** access or Valle Crucis.

Live stake giveaway will be early Fall. The funder is US Fish & Wildlife and they would like to have workshops.

NRCS David Tucker – No report

RC&D Chris Hughes – Thanked Jessica for volunteering at Field Day. Stated that StRAP will be getting \$20 million in funding this year. Watauga County is at the lower end of the funds. We need to identify a stream project. Discussion followed about removing stream debris and streambank restoration. Hughes stated that the Annual Meeting Date and information will be coming out soon.

**Division Report Rick McSwain** – McSwain gave updates on 9/26/23 DIC meeting. There was an update on StRAP and the High Rock Lake project. There was a discussion about the closing of the Paper Mills in NC with suggestions being made

as to how to use the byproduct. There are Resolutions from areas 7 &1 – these were discussed. The CET was successful. There were regional breakouts and lots of training opportunities to take advantage of.

David Williams gave a short report on the proposed budget increases for the programs stating that the budget should be final by October 2<sup>nd</sup>. He also spoke on funds from the USDA for Farmland Preservation Easements. Mikey Woodie asked about Ag Cost Share Allocations. Mr. Williams stated that should be discussed at the November Commission meeting. Mr. Williams stated that Rick McSwain is continuing to cover Area 2 while also covering Areas 8 & 3, 36 counties.

Mr. Williams stated that Watauga County will be hosting the Commission meeting on November 14<sup>th</sup> & 15<sup>th</sup>. Chris Hughes has reserved the Watauga County Commissioners room for both meetings. Buffett dinner on 11/14 at the Daniel Boone Inn at 4:30 with an estimate of 30 people.

Chris Hughes asked Michelle Kasey to update the County's website regarding the meeting dates. A discussion about the next Board meeting the morning of November 15<sup>th</sup> was held and it was decided that the meeting would be held as usual and wrapped up prior to the NC Soil & Water Commission meeting at 9am. A discussion followed on tours, presentations and lunch for the commission.
